**Winners:** 15 winning posters will be selected, one from each area development district. From these winners, 3<sup>rd</sup>, 2<sup>nd</sup> and 1<sup>st</sup> place winners will be selected. All winning designs will be turned into posters and displayed in the State Capitol during Victims' Rights Day activities on April 13<sup>th</sup>. Winning artists will also be recognized.

**Crime Victims Have Rights!** 2016 National Crime Victims' Rights Week Theme: Serving Victims, Building Trust, Restoring Hope.

**Poster Ideas:** Serving Victims, Building Trust and/or Restoring Hope for victims of: Child Abuse/Neglect, Physical or Sexual Assault, Human Trafficking, Dating Violence, Elder Abuse, Domestic Violence, Cyber Crimes, Homicide, Theft/Robbery, Drug related crimes, Drunk/Drugged Driving, etc.

**DEADLINE:** All posters must be postmarked by March 16, 2016 to be eligible for participation in the contest.

**The artist's name, age and parent(s)/guardian(s) name, address, e-mail address (if available) and phone number must be written on the back of the artwork. Artwork that does not include this information will not be eligible for the contest.**

## Crime Victims' Rights Poster Contest Rules and Requirements:

- Contest entrants must reside in the Commonwealth of Kentucky
- Artists must be 17 years of age or under
- Artwork must be 8.5" x 11"
- Only one entry per person
- The following art media may be used: crayons, colored pencils, watercolors, acrylic poster paint, and/or markers
- Original artwork only: no trademarked or copyrighted material or computer generated artwork will be accepted
- The artist's name, age and parent(s)/guardian(s) name, address, e-mail address (if available) and phone number must be written on the back of the artwork
- Artwork will NOT be returned to the artist
- Enlarged copies of the winning artwork will be displayed for public viewing in the State Capitol on April 13, 2016 during Kentucky's Crime Victims' Rights Day activities
- No inappropriate items may be used and/or displayed on the artwork; any artwork deemed inappropriate will not be entered in the contest or displayed for viewing
- By entering the contest the entrant and parent/guardian agree to the reproduction and display of their artwork during Kentucky's Crime Victims' Rights Day activities and for use in related publications, news features, blogs, social media, or other advertisements or promotional/awareness activities relating to the 2016 Crime Victims' Rights Poster Contest and other Crime Victims' Rights Day/Week related activities. I also understand that any written statements may be edited or used, in whole or in part, or adapted with other materials, and I hereby waive all rights of privacy, compensation, control, or royalties that I may have.

**Winners will be notified in late March.**

All participating artists **are invited to attend\*** Kentucky's 2016 Crime Victims' Rights Day Recognition Ceremony which will be held in the State Capitol Rotunda on Wednesday, April 13, 2016 beginning at 12:00 p.m. A reception will follow.
